EXPOSING PLANNED PARENTHOOD

Since the fall of *Roe v. Wade*, Planned Parenthood and the pro-abortion lobby have worked overtime to expand abortion pill access, preserve the flow of federal funding for abortion, and enshrine radical abortion-until-birth amendments into state constitutions.

**NOW IS THE TIME TO EXPOSE AND DEFUND PLANNED PARENTHOOD.
HERE ARE FIVE REASONS WHY:**

- **Planned Parenthood is the #1 provider of the #1 cause of death in America: abortion.** Over a million abortions were performed last year — and Planned Parenthood is responsible for nearly 40% of them, ending 392,715 little lives.
- **Planned Parenthood pushes “transgender services.”** Adding the business of sexual confusion and “transgender” hormone treatments to its repertoire of abominable practices, Planned Parenthood has been slapped with malpractice lawsuits from patients over alleged lack of informed consent and negligence.
- **Planned Parenthood brutally dismembers babies and sells them for profit.** Congressional hearings have been held to address this evil exploitation of babies. Videos show Planned Parenthood representatives haggling over the price of vital organs and casually describing ways of killing these little babies to ensure that their saleable organs remain undamaged.
- **Planned Parenthood endangers women's health by offering substandard care.** A New York Times exposé entitled “Botched Care and Tired Staff: Planned Parenthood in Crisis” highlighted several cases of gross negligence wherein staff endangered women's health with little to no remorse shown for the harm inflicted.
- **In short, Planned Parenthood harms women and kills children.**

Planned Parenthood received nearly \$700 million from U.S. taxpayers in 2023 alone.



While claiming to provide “health care,” Planned Parenthood has caused irreparable harm to women while killing their unborn children. Abortion (which is the opposite of health care) is its business model. Not only do they not deserve a *single cent* of taxpayer dollars, they should be facing criminal charges.

Conversely, hundreds of federally qualified health care centers and pregnancy centers offer care for women. Women will not lose access to needed health services by defunding Big Abortion.

As Senator Josh Hawley (R-MO) said, “Americans have long made it clear that they oppose taxpayer-funded abortions. . . Planned Parenthood and its affiliates receive tens of millions of dollars annually in federal grants . . . It’s high time we ended federal support for Planned Parenthood and the abortion industry.”

We can do our part and advocate that Congress defund big abortion through reconciliation NOW.

→ REBUTTAL TO

“Abortion is healthcare.”

There is nothing “healthy” about causing the death of a human being. A “successful” abortion kills a human being, therefore it is not “medically necessary” and is not “health care.” “Reproductive health” should not kill the natural result of reproduction.

→ REBUTTAL TO

“Abortion is good for women.”

Abortion leads to regret in post-abortive women and heightened mental health problems, including depression and anxiety, and more.

→ REBUTTAL TO

“Abortion bans end miscarriage care.”

A miscarriage and an abortion are vastly different. In a miscarriage, a preborn baby naturally dies, while in an abortion, a preborn baby is intentionally killed. While some women naturally miscarry, others require medical care to remove the preborn baby who died naturally in the womb. Miscarriage care to remove a baby who died naturally is medically necessary and is not an abortion. Therefore, it is not threatened by abortion bans.

→ REBUTTAL TO

“Abortion bans end treatment for ectopic pregnancies.”

An ectopic pregnancy occurs when a newly conceived baby implants outside the uterus, often in a fallopian tube. This condition is life-threatening for the mother and not viable for the baby, who cannot survive or be safely relocated. Treatment is necessary to protect the mother’s life, and in most cases, the baby has already passed away by the time the condition is discovered.

→ REBUTTAL TO

“Abortion doesn’t hurt babies.”

Not only does abortion kill a preborn baby, but the baby can feel the pain caused by the abortion procedure by at least 15 weeks of gestation and as early as 12 weeks gestation. As early as 8 weeks, the baby in the womb shows evidence of a pain response by exhibiting reflex movements during invasive procedures.

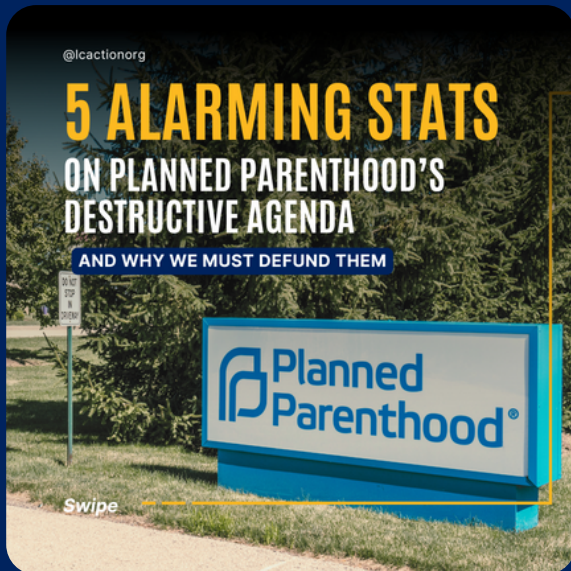
→ REBUTTAL TO

“The abortion pill is as safe as Tylenol.”

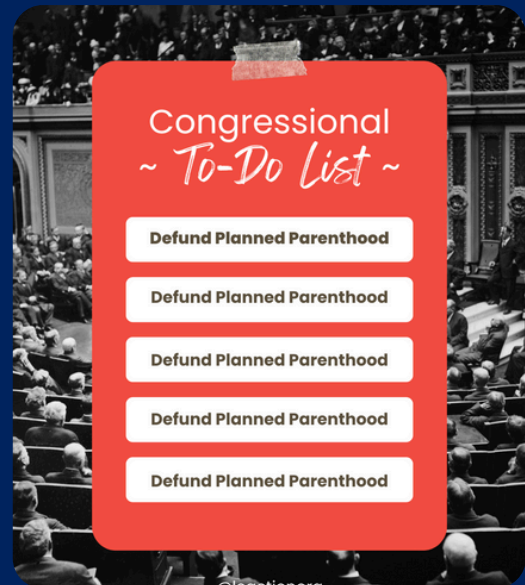
Mifepristone (aka RU-486) is incredibly dangerous and harmful to women and kills a preborn baby. The abortion pill is four times more dangerous than surgical abortion, has been associated with the death of at least 36 women, and caused thousands of adverse events.
