





- 3 groups of *female* rats BNT162b1, BNT162b2, and BNT 162b3
- Report claims "no deaths" but later in the study documents "3 unscheduled deaths".
- 1 female with labor complications, hunched posture, pale, marked piloerection, bleeding vulva/vagina distended/purple abdomen 4 dead of liter but this was "consistent with historical control".
- B1 group: 1 female w 15 pups (9 stillborn, 3 cannibalized, 1 dead, 2 missing). This was also categorized as 'normal" and "consistent with historical control groups".
- Increased pre-implantation loss higher in b2 / b3 groups (9.77% / 7.96%) compared to control (4.09%) but again this was written off as incidental.
- Exencephaly, open eye, and spina bifida in b1, gastroschisis in b2 (pictures below represent human corelates NOT actual vax injury)



- Implications are extremely concerning and could have ominous implications.














Czechia Live births by month of birth




Estonia Live births by month of birth




Czechia Live births by month of birth




Germany Live births by month of birth




Hungary Live births by month of birth




Portugal Live births by month of birth







Analysis of Vaccine Reactions After COVID-19 Vaccine Booster Doses Among Pregnant and Lactating Individuals

Survey data (as in V-safe) is dangerous and easily manipulated – often auto-populated

Selected population - over 50% were nurses and mainly white

"Most pregnant (97.6%) and lactating (96.0%) individuals *reported* no obstetric or lactation concerns after vaccination. This is NOT consistent with the <u>Pfizer 5.3.6 post-marketing data</u>

No query into the health of the baby or change in feeding habits in the online survey

Of the 4% of lactating women who had problems, the problems were not listed or quantified
